Councilmen Colberg returned to the meeting and resumed his position on the Council.

NEW BUSINESS #5: PAY AS YOU GO

A motion was made by Gene Fox to approve the Pay-As-You-Go road program list of prioritized streets. Earle Connell seconded and the motion passed.

NEW BUSINESS #6: SARA VENTURES LLC

Gene Fox made a motion to approve the Special Events Alcohol License for Sara Ventures LLC during the 2022 ADSFR. Rich Colberg seconded and the motion passed.

Discussion ensued which led to Gene Fox amending his motion to include the following ordinance wording changes: The fee will be levied, at a rate of twenty dollars (\$20.00) per square foot up to a maximum of twenty thousand dollars (\$20,000.00), on any Town of Dauphin Island approved wetland impacted property. NOTE: The Environmental Impact Fee will be assessed on the total square footage of the impacted wetland area within the lot, parcel, or plat where the activity is taking place and postpone action until next meeting. Trey Alderman seconded and the motion passed.

A motion was made by Gene Fox to adjourn. Rich Colberg seconded and the motion passed.
